MINUTES OF THE THOMAS TOWNSHIP LIBRARY BOARD OF TRUSTEES MEETING MARCH 21ST, 2024

THE MEETING WAS CALLED TO ORDER AT 4:00 P.M. BY MR. DOUGLAS BIRD, PRESIDENT, IN THE MEETING ROOM AT THE THOMAS TOWNSHIP LIBRARY, 8207 SHIELDS DRIVE, SAGINAW, MI 48609.

PRESENT: MR. DOUGLAS BIRD, PRESIDENT; MRS. LYNDA THAYER, SECRETARY/TREASURER; MRS. LUANN MARX, TRUSTEE; MRS. DONNA TROMBLEY, TRUSTEE.

ABSENT: MRS. JODI HOLLIS, VICE PRESIDENT; MRS. JANET KENNELLY, TRUSTEE; MS. JANET ADAIR, YOUTH SERVICES LIBRARIAN.

OTHERS PRESENT: MS.TARI DUSEK, LIBRARY DIRECTOR.

AGENDA: MRS. MARX MOTIONED TO APPROVE THE AGENDA AS PRESENTED, SECONDED BY MRS. TROMBLEY. THE MOTION WAS APPROVED BY ALL TRUSTEES.

MINUTES: THE FEBRUARY 15TH, 2024 MINUTES WERE REVIEWED. MRS. TROMBLEY MOVED TO ACCEPT THE MINUTES AS PRESENTED, SECONDED BY MRS. MARX. MOTION CARRIED.

BUDGET HEARING: AN AMENDED VERSION OF THE 2024/2025 BUDGET WAS PRESENTED. THERE WERE FOUR REVENUE LINE ITEMS THAT WERE AMENDED AND SEVEN EXPENSE LINE ITEMS THAT WERE REVISED. AFTER DISCUSSING THE CHANGES, MRS. THAYER MOVED TO ACCEPT THE 2024/2025 AMENDED BUDGET AS PRESENTED, SUPPORTED BY MRS. MARX. THE BUDGET WAS APPROVED BY ALL TRUSTEES, THE HEARING NOTICE FOR THE 2024/2025 BUDGET WAS PUBLISHED IN *THE SAGINAW VEWS* ON FRIDAY, MARCH 15TH, 2024.

FINANCES: THE MARCH 21ST, 2024 FINANCES WERE REVIEWED. EXPENSES INCLUDED THE PROPERTY/LIABILITY INSURANCE, PERIODICAL RENEWALS, SUMMER READING SUPPLIES, JOLETEC AND THE ADMINISTRATIVE FEE. INCOME INCLUDED FUNDS FROM THE EVA EARLE TRUST, GRAMS MEMORIAL LIBRARY FUND AND THE PPT REIMBURSEMENT FROM THE STATE OF MICHIGAN. THERE WERE NO FURTHER QUESTIONS OR COMMENTS. MRS. THAYER MOTIONED TO ACCEPT THE MARCH 21ST, 2024 FINANCES AS PRESENTED. THE MOTION WAS SUPPORTED BY MRS. TROMBLEY AND APPROVED BY ALL TRUSTEES.

THE FRIENDS OF THE LIBRARY CD HELD AT THE STATE BANK WAS RENEWED FOR TWELVE MONTHS AT 4.32% APY.

OPEN TO THE PUBLIC: NONE.

COMMUNICATIONS: HERBERT ROOFING WAS CONTACTED AND REPLACED SHINGLES BECAUSE OF NAIL POPS. RUSS TAYLOR WAS UNABLE TO STOP BY AT 3:30 TODAY TO DISCUSS THE PARKING LOT WITH MR. BIRD AND MS. DUSEK. THIS WILL BE RESCHEDULED. A LUNCHEON WILL BE HELD ON MARCH 26TH ACKNOWLEDGING JANET ADAIR'S DEPARTURE, AND DEBORAH SCHELL'S RETIREMENT. ON MARCH 20TH A PATRON WAS USING AN INTERNET COMPUTER NEAR CLOSING TIME. AFTER HE LEFT THE BUILDING STAFF DISCOVERED THAT HE HAD DEFACED THE TOP OF THE PONY WALL WITH A PEN. A POLICE REPORT WAS FILED THE FOLLOWING MORNING. MR. DUBY WILL SAND, FILL IN THE INDENTATIONS AND REPAINT THE TOP OF THE WALL.
